

Franklin Square Civic Association Community Yard Sale - Offline Seller Registration Form

The event will take place on Saturday, November 2th 2024,
from 10:00 a.m. to 3:00 p.m. (8:00 a.m. – 3 p.m. for Sellers) at Rath Park Pool Parking Lot.

The price per seller spot is \$25 for current-paid Franklin Square Civic Association Members, and \$50 for non-members. You may purchase up to three (3) additional seller spots if desired for a total of four (4) seller spots. Admission to the Community Yard Sale as a shopper is always FREE.

Sellers may line up your vehicles outside the park gate beginning at 7:30 a.m. Seller check-in will begin at approximately 8:00 a.m. No one will be permitted to drive into the lot after 9:00 a.m., and no refunds will be given for those who are late, or no-shows without prior approval from the event coordinator. Seller spots are equal to 4 parking spots. Your vehicle can be parked in one designated parking spot within your seller spot. If you have more than one vehicle you may unload the second vehicle at your seller spot, then it must be moved to the designated parking area outside of the yard sale area. Oversized vehicles (large box trucks (larger than 15ft), tractor trailers, pickups with trailers, or motor homes) are not permitted. If you will be purchasing more than one spot, please indicate on the form below. Additional spots must be paid for at the time of registration. No commercial vendors permitted. You must provide your own table(s), chair(s), tent(s) etc.

By submitting your signed registration form and payment, you agree that you have read the Rules and Regulations document and agree to abide by all Rules and Regulations as stated.
